# USEFUL INFORMATION!

## ACCEPTANCE OF THE SAMPLES IN THE CONTEST

**VINARIUM International Wine Contest 2026** is open to all categories and types of wine, as defined in the "International Code of Oenological Practices", which were produced in compliance with the legislation of the country of origin. Other special wines or grape-based products, must or wine, as well as spirituous beverages of vitivinicultural origin, will be admitted in the Contest.

Each wine sample or vitivinicultural product sample submitted to the Contest will consist of

- 4 bottles of 0.75 liters each, 0.5 liter or 0.375 liters each
- 3 bottles of 1.5 liters or 2 liters each.

All such samples need to be for sale and originate from a homogenous lot which is at the organizer's discretion, of 1.000 liters minimum. In certain cases, when the production of a certain wine is extremely limited (wines of botrytis grapes, ice wines, wine collection, etc.), a limited volume, but no less than 100 liters, can be permitted on grounds of low production.

## PARTICIPANTS

Wine makers, retailers, négociants, professional/employers' associations, from wine-producing countries across the globe.

## THE REGISTRATION FEE

▶ 1-5 entries	90 euro/ entry
▶ 5+ entries	80 euro/ entry

\*For Romanian companies, add 21% VAT.

\*\*For EU countries: no VAT is applicable if the VAT number is stated on the Participant Registration form.

\*\*\*For non-UE countries: VAT isn't applicable.

The registration fee does not include shipping and customs fees.

# SAMPLES REGISTRATION

## PREPARING THE REGISTRATION DOCUMENTS:

- 1 Complete the samples' list to be registered
  - 1 Save to your computer, to be able to attach to the Product Registration Form:
    - Analysis Certificate for each sample in .docx, .doc, .pdf, .jpg or .zip, format, max. 2 MB/file
    - Images of front and back label in .jpg, .jpeg, .png or .gif format, max. 2 MB/file
- Note! It is sufficient to send simple images of front and back labels – captured even with your smartphone.**

## ONLINE SAMPLE REGISTRATION:

- 1 Create the Participant account (fill in company's information).  
If you have previously created an account, access it.

  - 1 Fill in the Product Registration Form based on information from Analysis Certificate
  - 1 For each registered product, the app will require to attach:
    - Front Label
    - Back Label
    - Analysis Certificate
- Important!** If the files containing labels' images have been attached correctly, they will appear directly on the Product Registration Form and it will **NOT BE NECESSARY** to add the labels in the envelope that will accompany the samples' package.production.
- 1 After adding the last product, click on FINALIZE
  - 1 Print and sign the Participant Registration Form and Product Registration Form. These must accompany the delivered samples' package
  - 1 For payment, you can choose between CARD PAYMENT or PAYMENT ORDER
  - 1 Registration is automatically confirmed to the organizers; the documents will be checked, the invoice is sent via email, together will all necessary delivery instructions.

# SAMPLES DELIVERY

## THE PACKAGE(S) WILL CONTAIN:

- 4 bottles for each sample, well packaged, in order to avoid breaking during transport
- A single envelope containing all documents: Participant Registration Form, Product Registration Forms, Analysis Certificates. This envelope will be placed in one of the packages, on which it will be specified: **CONTAINS DOCUMENTS**. This package will be firstly opened when receiving the samples.  
**Important:** If the files containing labels' images have been attached correctly during the registration process, they will appear directly on the Product Registration Form and it will **NOT BE NECESSARY** to add the labels in the envelope that will accompany the samples' package.
